**NOTICE OF FILING SUPPLEMENTAL NOTICE OF BAR DATE**

PLEASE TAKE NOTICE that on November 3, 2023, the above-captioned debtor and debtor in possession Clover Fast Food, Inc. (the “**Debtor**”) filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code.

PLEASE TAKE FURTHER NOTICE that on November 9, 2023, the Court entered the *Order Pursuant to 28 U.S.C. § 156(c), Bankruptcy Code Section 105(a) and Local Rule 2002-1(f), Authorizing Appointment of Reliable Companies d/b/a/ Reliable as Claims and Noticing Agent, Effective as of the Petition Date* [Docket No. 32] which appointed Reliable Companies d/b/a Reliable (“**Reliable**”) as the Debtor’s claims and noticing agent in this case.

PLEASE TAKE FURTHER NOTICE that on November 10, 2023, the Debtor filed the *Notice of Chapter 11 Bankruptcy Case* [Docket No. 43] (the “**Notice of Commencement**”) which was served on the Debtor’s list of creditors. In accordance with the *General Order Setting Proof of Claim Bar Dates in All Cases Under Subchapter V of Chapter 11* of the Bankruptcy Court for the District of Delaware (entered September 14, 2021), the Notice of Commencement notified creditors of the general and governmental bar dates for filing claims in this chapter 11 case.

PLEASE TAKE FURTHER NOTICE that, pursuant to the Notice of Commencement, the general bar date for creditors to file a claim in this chapter 11 case is **January 2, 2024** (the

“**General Bar Date**”) and the governmental bar date is **May 1, 2024** (the “**Governmental Bar Date**”). Notice of Commencement ¶ 8.

PLEASE TAKE FURTHER NOTICE that pursuant to rule 3003-1(a) of the Local Rules for Bankruptcy Practice and Procedure for the Bankruptcy Court for the District of Delaware, parties wishing to file a claim in this case should submit the proof of claim to Reliable, the Debtor’s claims agent, electronically or by mail.
